SUBJECT: REQUEST FOR ACTION ON HISTORIC LABOR LAW REFORM

LEGISLATION - Protecting the Right to Organize (PRO) Act

Brothers and Sisters:

Labor's success in electing pro-worker candidates in the 2020 elections has given us a rare opportunity to fix our nation's weak and ineffective labor laws.

I am asking your local and members to join the labor movement's nationwide campaign to pass the **Protecting the Right to Organize (PRO) Act** (H.R. 842, S. 420), historic and powerful labor law reform legislation.

For decades, employers have used intimidation, retaliation, threats and surveillance to deny workers the right to join a Union and negotiate a contract. The PRO Act will make fundamental changes to the nation's labor laws that will give workers a fair chance to enjoy the benefits of Union membership and a better life that comes with a collective bargaining agreement.

Bringing workers into the BCTGM through organizing is the only way to maintain the wage and benefit standards our members have earned over decades of tough negotiations and struggle. The more non-union shops there are in our industries, the tougher it is for us at the bargaining table and the easier it is for employers to shift production out of BCTGM shops.

This is why we must organize non-union shops in all of our industries. Passing the PRO Act in Congress is essential to achieving this critical goal.
